REGIONAL DISTRICT OF OKANAGAN-SIMILKAMEEN

BYLAW NO. 1471, 1994

A bylaw to amend the Regional District of Okanagan-Similkameen Sterile Insect Release Extended Service Establishment Bylaw No. 1101, 1989.

WHEREAS pursuant to Section 802 of the Municipal Act, a Regional District may amend a bylaw establishing an extended service;

AND WHEREAS the Regional District of Okanagan-Similkameen by Bylaw No. 1101, cited as "Regional District of Okanagan-Similkameen Sterile Insect Release Extended Service Establishment Bylaw No. 1101, 1989" established the sterile insect release extended service with the City of Penticton, the District of Summerland, the Town of Osoyoos, the Village of Oliver, the Village of Keremeos and a portion of Electoral Areas 'A', 'B', 'C', 'D', 'E', 'F and 'G' as participating members;

AND WHEREAS the Regional Board of the Regional District of Okanagan-Similkameen wishes to amend the limit established by Bylaw No. 1101;

AND WHEREAS the Directors of Electoral Areas 'A', 'B', 'C, 'D', 'E', 'F' and 'G' have consented, in writing, to the adoption of this bylaw pursuant to Section 802(1)(b) of the Municipal Act;

AND WHEREAS the councils of the City of Penticton, the District of Summerland, the Town of Osoyoos, the Town of Oliver and the Village of Keremeos have consented, in writing, to the adoption of this bylaw pursuant to Section 802(1)(b) of the Municipal Act;

NOW THEREFORE the Regional Board of the Regional District of Okanagan-Similkameen in open meeting ENACTS as follows:

1. AMENDMENT

That Section 5 of "Regional District of Okanagan-Similkameen Sterile Insect Release Extended Service Establishment Bylaw No. 1101, 1989" be deleted and replaced with the following:

5. LIMIT

The amount of the annual requisition referred to in Section 3(b) shall not exceed the product of 34 cents per thousand of actual assessed value of land only within the participating areas, on the basis provided by Section 26 of the Hospital District Act.

2. <u>CITATION</u>

This bylaw may be cited as the "Sterile Insect Release Extended Service Amendment Bylaw No. 1471, 1994".
