

## COLUMBIA SHUSWAP REGIONAL DISTRICT

### BYLAW NO. 5217

#### A bylaw to amend "Columbia Shuswap Regional District Sterile Insect Release Extended Service Establishment Bylaw No. 5001"

WHEREAS the Board of the Columbia Shuswap Regional District has, by "Columbia Shuswap Regional District Sterile Insect Release Extended Service Establishment Bylaw No. 5001", established an Extended Service Area, for the purpose of participating in the Okanagan/Kootenay Sterile Insect Release program under the direction of the Okanagan/Kootenay Sterile Insect Release Board, with the District of Salmon Arm and parts of Electoral Area 'D';

AND WHEREAS Section 802(1)(b) of the Municipal Act provides that a bylaw establishing an extended service may be amended with the consent of at least 2/3 of the participants;

AND WHEREAS it is deemed desirable to amend Bylaw No. 5001 to include representation by alternate directors;

NOW THEREFORE the Board of the Columbia Shuswap Regional District, in open meeting assembled, HEREBY ENACTS as follows:

1. Section 2 of Bylaw No. 5001, cited as "Columbia Shuswap Regional District Sterile Insect Release Extended Service Establishment Bylaw No. 5001", is hereby repealed and the following substituted therefor:
  - "2. a. The Sterile Insect Release Board will be comprised of one member appointed annually by each participating Regional District from its participating municipal/Electoral Area Directors or Alternate Directors. The Regional District may, from the same group of Directors or Alternate Directors, designate an alternate to its appointed member to take the place of, vote, and generally act in all matters for the absent member. The non-voting members of the Board shall be those provided by Regulation made by the Lieutenant Governor in Council and appointed in accordance with the said Regulation.
  - b. Where the seat of a voting member becomes vacant through death, resignation or disqualification, the Chairperson shall promptly appoint another member in his or her place in the manner set out in Section 3. a. The Alternate may continue to take his or her place and vote until another representative has been appointed.
  - c. The appointment of the voting members of the Board shall take effect on the first day of January in each calendar year and shall remain in effect for the duration of that calendar year or until such time as his or her successor has been appointed, whichever shall sooner occur."

2. This bylaw may be cited as "Columbia Shuswap Regional District Sterile Insect Release Extended Service Amendment Bylaw No. 5217."




