

REGIONAL DISTRICT OF NORTH OKANAGAN

BYLAW NO. 1385

To amend the Sterile Insect Release Extended Service Establishment Bylaw No. 834 to include the City of Enderby, Village of Lumby, and Electoral Areas "D", "E" and "F", and to establish terms for the recovery of costs

WHEREAS the Regional District of North Okanagan has, by "Sterile Insect Release Extended Service Establishment Bylaw No. 834, 1989", established an Extended Service Area, for the purpose of participating in the Okanagan/Kootenay Sterile Insect Release Program under the direction of the Okanagan/Kootenay Sterile Insect Board, with the City of Armstrong, City of Vernon, District of Coldstream, Township of Spallumcheen, and parts of Electoral Areas "B" and "C" as participating member municipalities;

AND WHEREAS the City of Enderby, Village of Lumby, and Electoral Areas "D", "E" and "F" have now given their consent in accordance with Section 799 and 800 respectively of the *Municipal Act*;

AND WHEREAS Section 802(1)(b) of the *Municipal Act* provides that a bylaw establishing an extended service may be amended with the consent of at least 2/3 of the participants;

NOW THEREFORE the Regional Board of the Regional District of North Okanagan in opening meeting assembled enacts as follows:

1. That Bylaw No. 834, being the "*Regional District of North Okanagan Sterile Insect Release Extended Service Establishment Bylaw No. 834, 1989*" be hereby amended as follows:
 - (1) That Section 1(a) be deleted in its entirety;
 - (2) That Section 1(b) be changed to 1(a);
 - (3) That Section 4 be amended by:
 - Adding after "City of Armstrong" the following:
 - "The Corporation of the City of Enderby
 - The Corporation of the Village of Lumby
 - Electoral Areas "D", "E" and "F","
 - (4) That Paragraph 2 of Section 6, beginning with "Secondly, ..." be amended by:
 - Adding the following to the end of the paragraph "with the exception of the Corporation of the City of Enderby, the Corporation of the Village of Lumby, and Electoral Areas "D", "E" and "F";"

(5) That a new paragraph be added to Section 6 as follows:
"Thirdly, the amount of the annual operating and debt servicing costs that are apportioned to the Regional District of North Okanagan in accordance with Section 8 shall be raised by a property tax on land only. The property value tax shall not exceed 10 cents per \$1,000. of net taxable values for land only within the Corporation of the City of Enderby, the Corporation of the Village of Lumby, and Electoral Areas "D", "E" and "F" for Regional Hospital District purposes.

2. This Bylaw may be cited as "*Regional District of North Okanagan Sterile Insect Release Program Extended Service Amendment Bylaw No. 1385, 1996*".




