#### 5.1 Staff Report from Michelle Cook, General Manager, September 26, 2024, re: Program Update

Ms. Cook presented the staff report to the Board in detail.

Production has now been reduced to off-season colony levels and the facility if down to one shift a day. Field Supervisors are now entering data and notes from the season into the database and preparing to make decisions about the service levels for each orchard property for the 2025 field season.

The CCLSP is just over a year into its cross-commodity work. In September, the Cross-Commodity Advisory Council endorsed five funding applications. Two of these applications included two years of ongoing operational funding for the BC DAS program, which SIR hosts, and a feasibility study for expansion of BC DAS to wine grapes.

Some renewed interested from New Zealand to receive some small shipments this coming winter was reported. Confirmation that the facility has the capacity to provide supplemental winter moth shipments without additional staff was confirmed.

#### 5.2 Report from Evan Esch, Program Entomologist, Re: Preliminary 2024 Season Results:

Mr. Esch presented the 2024 preliminary season results.

The cold winter did not negatively impact the overwintering codling moth population. The warm summer was conducive to pest population growth during the 2nd generation, but 3rd generation activity was limited this year.

Overall, more wild moths were captured in 2024 than in 2023. This was partly due to improvements to our traps and partly due to actual increases in wild populations. The program found codling moth increases in areas with historically very low pest populations, including Oliver, Cawston and Keremeos. Efforts to contain codling moth increases in those areas were made and will continue into 2025.

Of note, the spread of codling moth by infested bins occurred this season. Mr. Esch and the SIR field staff have worked closely with packing houses to assist them in identifying and treating infested bins to eliminate/limit the spread of coding moth.

Director Lavery expressed thanks to the SIR team for their extensive work reducing a significant codling moth infestation in Salmon Arm.

### 7.2 Proposed 2025 Tax Increase

The proposed value tax increase of 4% was discussed by the Board.

Year-over-year increases to the value tax have been included in the five-year financial plans since 2021. Prior to that, the Board had kept a \$1.7M value tax revenue cap in place from 2010- 2021, falling behind inflation and relying on reserves to fund shortfalls. Sales revenues have been growing and contribute impactfully to covering program expenses, but tax increases continue to be needed this year and into to future to cover the full costs of the program.

## 7.4 Memo from Melissa Tesche, BCFGA General Manager, dated September 26, 2024, re: Tree Fruit Industry Report

Melissa Tesche, BCFGA GM, gave a brief report about the state of the tree fruit industry after the unexpected midsummer closure of BC Tree Fruits (BCTF). All BCTF growers were directed to find alternate homes for their apple crops this year. Individual growers needed to find a new packer, achieve independent food safety certification, obtain bins to pick crops into and find a new source of horticultural support. A lack of cold and controlled

atmosphere storage for the crop and potential pricing challenges from the market added to the chaos.

It was concluded that it is too early to tell how these changes might impact apple acreages in the future but that the apple sector will undoubtedly look different next year.

Grower Tarsem Goraya, as a prior member of the BCTF Co-op, expressed frustration with the lack of government financial support and operational oversight provided to the cooperative in the years leading up to the collapse.
